# **President's Report:**

#### **Treasurer's Report:**

- Account Balances As of December 31<sup>st</sup>, 2015, balances of all accounts are healthy.
- Reserve Study Met with Morrison Hershfield to review reserve study for 2016/17 F.Y.
  Two options were provided; proposed scope and an alternative. The alternative proposal
  is called "zero balance" just keeping enough in reserves to pay expenses, and not
  maintain a significant cash buffer. BOD will discuss the Reserve Study and budgets in
  March 2016, and will be asking for homeowner input.
- Financial Reviews Verity Accounting is continuing to review the accounts of Fiscal Years 2013/2014 and 2014/2015. BOD will schedule a meeting to review compiled financials at Verity Accounting. Verity will make recommendations as to future accounting, and Turner will work with Foster & Associate Accountants to implement their suggestions.

- Construction Loan Amy explained nature of the bank loan, discussed the past special assessment and the need for the loan after multiple new row house owners inquired.
- Collection Activity -
  - There are 8 accounts in arrears with our attorney for current owners.
  - o There are additionally 11 collection accounts with our attorney for past owners.
- ACH Auto Draft of monthly dues (ACH) review. There are currently 17 participants. 40 participants are needed to break even with the banking charges. BOD will consider the continuation of this service at their next meeting.

## **Committee Reports:**

- *Landscape* Routine maintenance planned tree trimming, shrubs, pest control, turf moss treatment and fertilization.
- *ARC* An ARC Request (Architectural Review Committee) is anticipated from a Rowhouse owner regarding installing a gate in a Rowhouse backyard. When fences are replaced on Silo, BOD may consider install or allowing gates, and Homeowner approval may be needed. We are also anticipating a request for Flood lights in the backyard, to move outdoor lights to the front of the Rowhouse, and painting the front steps for safety.
- *Compliance* No open compliance issues; will review and send to Turner as issues occur rather than on a scheduled basis.

#### **New Business:**

- Review of interior water shut off valves for hose faucets in homes:
  - O Hose bib in backyard shutoff is under kitchen sink.
  - Hose bis in front/side of house:
    - If there is a first floor bathroom at the front of the house, the shutoff is in that bathroom.
    - If there is not a first floor bathroom in the front of the house, the shutoff is upstairs in the master bathroom.

#### **Elections:**

- Nominations for 2 year term to Board of Directors: Amy Boyle, Amanda McMillen, and Kelly Pastore.
- Amy Boyle and Amanda McMillen were elected to the board of directors to serve for 2 year terms.

## **Open Forum:**

- Homeowner forum discussed a variety of association topics to include noise, speeding, and parking.
- Concerns about the neighboring apartments, and drug dealing in the parking lot. HOA will approach the Sherwood Police. If no result, then the City Council.
