# **President's Report:**

 Courtney Atwood encouraged all homeowner's to hold on to their questions and comments until the end of the meeting during our Open Forum so as to keep our Board meetings on task and timely.

## **Treasurer's Report**

- Amy Boyle summarized the Association's financial status to date.
- The September financials have been reviewed and returned to Turner Northwest for amendments.
- The Board will be making an extra payment towards the principal on the row house reconstruction loan from homeowner Opt C payoffs. This will decrease the term of the loan however; we are limited to 20% of the loan value annually.
- Ihde & Ihde CPA has been contracted to perform an independent financial review for our fiscal year 2012 financials.

# **Committee Reports:**

## Architectural Review Committee

- A walk-through of the single family homes was recently performed and over half were found to be in need of new paint. Amy recommended that a courtesy notice be sent to all affected homeowners, notifying them of the need to repaint as per the Association's CC&R's. Amy will draft the notice and provide to Turner for disbursement.
- Discussion regarding the possibility of a group discount should homeowner's wish to join together was discussed and Amy will follow up with local paint contractors to obtain rough estimates.
- Further follow-up with homeowners will occur in late winter and will outline timelines and requirements.

# Landscape Committee

- All neighborhood tree-trimming has been completed.
- The City of Sherwood has yet to replant the bed along SW Century and SW Langer Farms Parkway. Amy will follow up with the City representative to obtain a timeline for replanting.
- Irrigation has been turned-off and Amy recently handed over maintenance of the irrigation system to Grounds Northwest. In the spring, should you have issues with your front yard irrigation, please contact the Board as usual.

# Compliance Committee

- Board members will be conducting community walk-throughs the first and third Mondays of every month to monitor compliance of the Association's CC&R's. Violations will be forwarded to Turner Northwest for notification to homeowners.
- The Board is working on obtaining a notice which can also be posted to front doors when a violation occurs. Amy will follow up on this option.

# **Unfinished Business:**

- Rowhouse gutters will be cleaned and moss treated on roofs Monday, November 18th and Tuesday, November 19th by Snugs Pro Wash.
- A solar motion sensor was installed in the alley at the end of Holland Ln and the park bench was removed to guard against further loitering and littering. This has mitigated the problem.
